

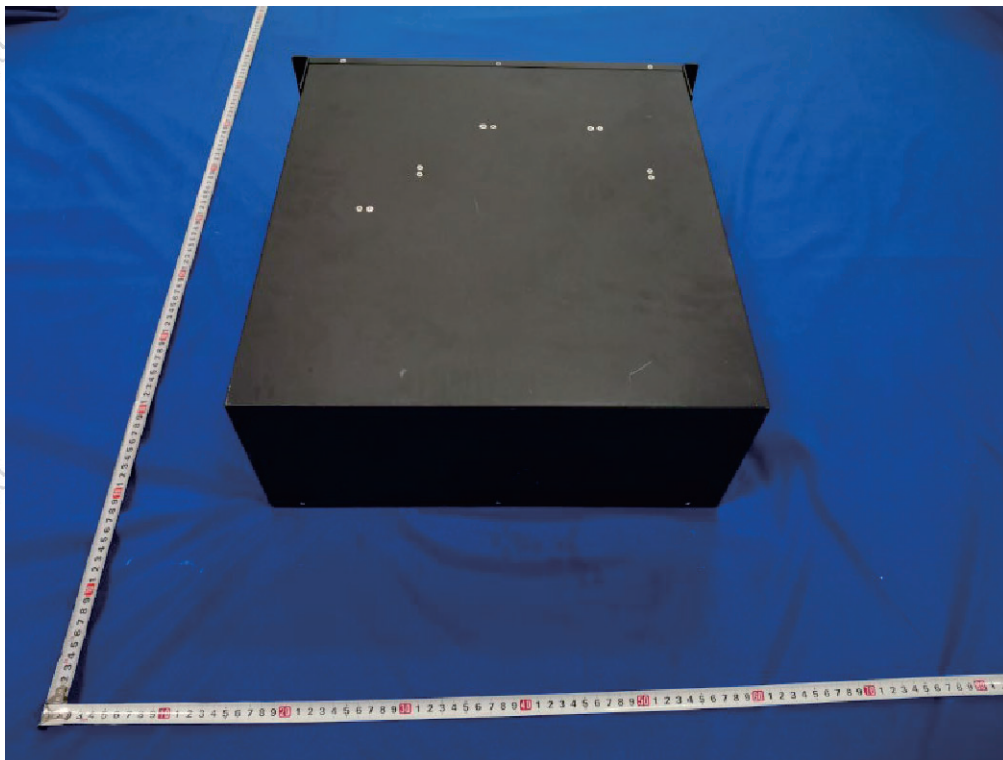


Figure 2 Overall view II of battery (电池外观图II)

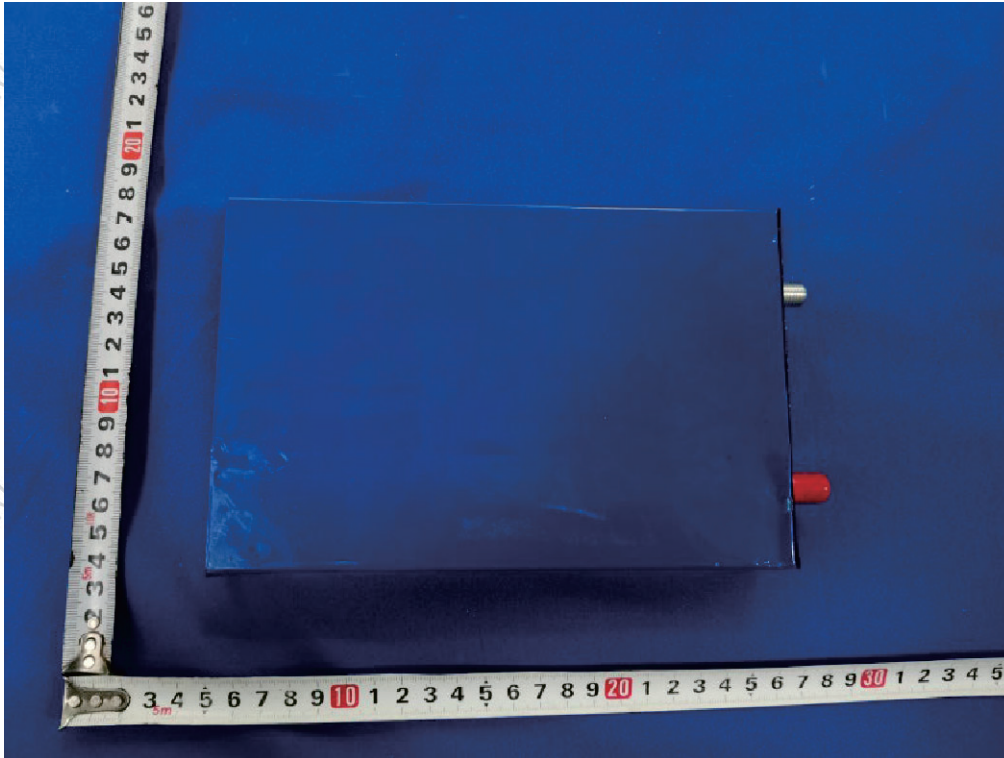


Figure 3 Overall view of cell(电芯外观图)
