7.Precautions

- 1) For single patient use only.
- 2) Store in a dark, cool and dry place.

8.Warning

1)The product can be used only once, should be used immediately after opening the package and destroyed afterwards; if it is reused, the users or patients can be infected, patients have adverse reactions such as irritation and sensitization.

2) The product finked or affected with damp cannot be used. It should locate in the place where is abstained from high temperature and high humidity, and from caustic gases, and have good dryness and ventilation.

3) The product must be used within the validity period.

4)According to classification of medical waste, wastes of the production are Infectious wastes. They shall be classified and divided into packages or containers.

9.Instruction for use

1) Open the package, take out the cotton swab, and don't touch the cotton tip

2) It is suitable for mechanical barrier and absorbing exudate.

Absorbent cotton The composition: The swab head: Absorbent cotton100% The swab rod: Wood(Birch100%)

11.Storage conditions

Should be stored in a well-ventilated room without corrosive gas.

12.Transport Conditions

Sunscreen and rainproof during transportation
